The subject was transported to the hospital for psychiatric treatment. It was later discovered the subject was responsible for a theft which occurred on 06/27/2024 at another store. Warrants were applied for and issued for the subject with a \$75,000 bond. |
| Property Damage | 07/11/2024 | 2000 Blk. S. Lindbergh Blvd. | A subject reported that his vehicle was damaged while parked at a business. This case is under investigation. |
