A. CALL TO ORDER

The July 20, 2021 regular meeting of the Ways and Means Committee of the City of Frontenac was called to order at 3:00 p.m. The meeting took place via video and teleconference.

B. ROLL CALL

H. REVIEW OF FINANCIAL REPORTS

June 2021

Ms. Bennett presented the financial report information, which is attached. She stated revenues will change because of accruals in July and August. The amount of money the city will receive for the America Rescue Plan, is estimated to be \$652000. One half of what we will receive, \$326,000 is likely to come in FY21-22 and the second half is likely to come in FY22-23. Additional discussion occurred regarding real estate taxes and P.I.L.O.T. payments.

Ms. Bennett also discussed the unrestricted cash amounts.

I. OLD BUSINESS:

Sales Tax Trends

Ms. Bennett presented information on the sales tax trends. Currently we are ahead on revenue and ahead of last year. Ms. Bennett stated with sales tax comparisons for FY19 to FY 21, April is ahead 2.43% and May is ahead 10.56%. The Wayfair bill was discussed, Mayor Hatfield and Mr. Christensen said we will begin receiving funds in January 2023.

Ms. Bennett had no update.

Mr. Christensen stated there is no update at this time.
